Mayor McCleish opened the meeting at with the Pledge of Allegiance at 7:00 PM.

Roll call was taken with Robert Richter, Jeremy Fraker, Barb Schemmel, and Corey Rasch. Richard Arndorfer was absent. Staff present was Crysti Neuman, City Director, Tim Rowlet, Utility Clerk, Mark Reimers, Streets. Guests present were Mike Smith and Ronnie Becker.

Motion by Rasch, second Fraker to approve agenda. All approve. Motion carried.

Motion by Richter, second Rasch to approve consent agenda. All approve. Motion carried.

Motion by Rasch, second Schemmel to approve bills. All approve. Motion carried.

Mike Smith expressed concern about the alley to between the 400 block of Portland St and Morehouse ST. Only two homes on the north end of alley need access. People drive through and are tearing up yards. Ideas were discussed to resolve this problem. A meeting will take place on June 27, 2016 at 6:00 PM with the homeowners affected.

Motion by Schemmel, second Richter to approve North Union Post prom Committee to sell snow cones and cotton candy once a week. All approve. Motion carried.

Motion by Schemmel, second Rasch to close Portland Street between Nymans and Main Street Pub and Grill for July 3<sup>rd</sup> and 4<sup>th</sup>. All approve. Motion carried.

Motion by Rasch, second Schemmel to approve Liquor license for Main Street Pub and Grill. All approve. Motion carried.

Motion by Fraker, second Rasch to approve tobacco license for Hager Foods, Bancroft Cargo, and Bancroft Liquor Store. All approve. Motion carried.

Motion by Rasch, second Schemmel to approve hiring of Joyce Van Haastert for EMS duties: All approve. Motion carried.

A meeting will take place on June 27, 2016 at 6:30 PM with the homeowners affected on the west side of Morehouse Street.

No action was taken by council on job descriptions or salaries.

1<sup>st</sup> Reading of Ordinance 6-13 to Rescind and reinstate Ordinance 6-13 an Ordinance Amending the Code of Ordinances of the City of Bancroft, IA by adding provisions pertaining to Storm Water Drainage District Utility Paid Service was read. Motion by Rasch, second by Richter to waive the second and third readings. Roll Call vote; Richter-aye, Rasch-aye, Schemmel-aye, Fraker-aye. Motion carried 4-0.

Motion by Richter, second Fraker, to approve Resolution 2016.06.01. A Resolutions of Transfers between between Funds for a total of \$97,754. Roll Call vote: Richter-aye, Rasch-aye, Schemmel-aye, Fraker-aye. Motion carried 4-0.

City renting the Ambulance and Police Bay from Bancroft Foundation for \$800 per month beginning 11-1-16 died for lack of motion.

Council would like to ask Brian Hatten and Brad Arndorfer to come to July Council meeting to discuss progress on new fire building.

Council will evaluate possible improvements at Memorial park at the end of the season.

Tabled new truck purchase

Schemmel would like to see the cost on adding the installed warning lights, electric power inverter and up fitter switches. This item was tabled.

Motion by Rasch, second Schemmel to approve a donation of \$250.00 to Blake Crawmer for educational trip to Costa Rica. Fraker abstained. Motion carried. 3-0.
